What's happening now?

An Asheville In Motion Plan charrette was held in March 2015. The objective of the charrette was to bring the project consultants to Asheville and brainstorm multimodal transportation solutions with staff and the community. Consultants and staff from multiple departments selected eight corridors and worked as a team to explore the possibilities and potential in each corridor.

Since the charrette, the consultants have completed the draft plan and prioritization tools. Community members are asked to watch the introductory video, read the draft plan, and provide their input at [Open City Hall](#). Why it's happening

The City of Asheville faces familiar and emerging challenges due to a growing population, employment, and tourism base. Accommodating growth through outward expansion is not practical, especially given the unique lay of the land and the expense (and limited resources) of constructing new roads. The Asheville In Motion Plan is an important community-driven step to absorb and enhance growth in a way that balances travel needs and creates true choices among the City's mobility options.

The City's expressed goal is to create an effective and progressive plan that encourages health-oriented and sustainable transportation, reduces barriers to access transportation, and connects residents and visitors with the places they want and need to go with improved safety, efficiency, and accessibility.
