is stated that the funds in the pool are only to cover loan defaults.

IV. **Proposal:** Approve Loan Maintenance and Reporting Guidelines

Discussion: Committee must tell borrowers that coaching and technical assistance are required and that lenders will be held accountable to provide this coaching and technical assistance. There were questions as to how we are evaluating this coaching and technical assistance – this is provided in the loan documentation that requires the applicant to participate. The Committee will be kept abreast of how this coaching/technical assistance is going when applications (with personal information redacted) are reviewed. Tim noted that the status of this fund will be reported to Commissioners on a quarterly basis and as such we may need to set a realistic
